

**ST. REGIS MURAL MIXED MEDIA COMPETITION**  
**Fortress Real Developments and Edenshaw Developments**  
For the purposes of this competition known as **Fortress/Edenshaw**

1. Eligibility: This Campaign is open only to those who sign up at [connect@fortressrdi.com](mailto:connect@fortressrdi.com) The Campaign is only open to legal residents of Winnipeg, MB, and is void where prohibited by law.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements.

3. Campaign Period: Entries will be accepted starting on August 16<sup>th</sup> 2017. All entries must be received by September 15<sup>th</sup> 2017 by 5:00PM (CST). Entry details will be provided once you sign up through [connect@fortressrdi.com](mailto:connect@fortressrdi.com)

4. How to Enter: The Campaign must be entered by submitting an entry to the details provided to you upon signing up for the competition. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified. You may submit multiple entries. You must provide the information requested.

5. Prizes: The Winner(s) of the Campaign (the “Winner”) will be awarded the prize of their winning artwork to be displayed in the lobby of the new building upon completion of construction. The prize for this competition has no cash value. The prize is nontransferable. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Fortress/Edenshaw to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a judging panel at an event date to be determined later. Winner will be invited to attend the event where winners will be selected. If Winner cannot be contacted, is ineligible, fails to claim the prize, or fails to timely return a completed and

executed declaration and release as required, the prize may be forfeited and an alternate Winner selected.

8.
